On last day of Monsoon Session, triple talaq bill to be tabled in Rajya Sabha

NEW DELHI: The much-debated Triple Talaq Bill will be tabled in Rajya Sabha on Friday a day after Union Cabinet approved an amendment to the bill.

The Union Cabinet on Thursday proposed three changes in the Muslim Women Protection of Rights on Marriage Bill, 2017 - first, only the victim, a blood relation or relation by marriage are allowed to lodge FIR in the case, second, the case can be dropped if husband and wife agree to settle their differences and third, a magistrate can grant bail to men found guilty of giving instant triple talaq to their wives.

However, the offence still remains non-bailable. If the amended bill is passed in the Upper House, it will have to go back to Lok Sabha for approval of the amendments.

On December 29, the Lok Sabha passed the bill which seeks to make instant triple talaq a criminal offence, a day after Prime Minister Narendra Modi-led National Democratic Alliance (NDA) government tabled it in the lower house. The Bill proposes a three-year jail term for a Muslim man who divorces his wife in any form of spoken, written or by electronic means such as email, SMS, and WhatsApp.

Triple talaq, or verbal divorce, is practiced by a section in the Muslim community to instantly divorce their wives by uttering 'talaq' three times.

Ahead of Independence Day, explosives seized in Delhi, terror suspects nabbed in Bengaluru

NEW DELHI: Ahead of the Independence Day celebrations, the authorities have seized a huge cache of arms and ammunition from two places in national capital while a suspected Bangladeshi terrorist was nabbed in Bengaluru. According to reports, a huge cache of arms and ammunition, including carbines and cartridges, were recovered from two suspected arms peddlers in two separate operations by the Delhi Police late on Thursday. The two accused have been identified as Mohammad Azimuddin Sheikh and Azim, a resident of Malda in West Bengal and Soyyam alias Aas Mohammad, a resident of Shamli in Uttar Pradesh.

Sharing details of the police action with media, Sanjeev Kumar Yadav, Deputy Commissioner of Police (Special Cell) said, "Soyyam was arrested from Singhola village on GT Karnal road on Thursday while Azim was arrested earlier this week from northwest Delhi." The accused were involved in supplying arms to Delhi-based criminals for the last four-five years, the official said.

With just few days left to the Independence Day, the Special Cell of Delhi Police has been keeping a tight vigil on the movement of arms suppliers and those with suspected terror links. The recovery of the arms and ammunition leading to the arrest of the two suspects is part of our vigil, the officer said.

"The Special Cell has launched a drive against supply of illegal firearms in Delhi from other parts of the country. Concerted efforts have led to busting of several gun selling rackets and seizure of huge cache of sophisticated/semi-automatic weapons," the officer said. According to the DCP, the teams of the Special Cell have successfully busted two interstate gun-selling rackets with the recovery of large cache of arms and ammunition from the accused. Azim was arrested by one of the teams of the Special Cell on August 6 following a tip-off, he said.

Azim along with Akil had come to deliver the huge consignment of illegal firearms to Hazi Kayum in Delhi. Following specific inputs, a team laid a trap at the vantage points near Tara Chowk, Dheerpur in northwest Delhi here, the officer said. Around 11.55 am, Azim was found waiting for Kayum, carrying two trolley bags.

Even Lord Ram once left Sita over doubt: Congress MP Hussain Dalwai on triple talaq bill

NEW DELHI: Even as the Narendra Modi government prepares to push the triple talaq bill in the Rajya Sabha, a senior Congress leader on Friday compared the sufferings of Indian Muslim women with that of Goddess Sita who was abandoned by her husband Lord Ram. The remarks were made by Congress MP Hussain Dalwai, who also called for further modification in the Muslim Women Protection of Rights on Marriage Bill, which criminalises instant divorce. Speaking to Zee News, Dalwai said, "The Modi government is not interested in the welfare of Muslim women. The government's promise of giving more rights to the Muslim women and empowering them is just an eye-wash."

Though the Union Cabinet has proposed three changes in the Muslim Women Protection of Rights on

Marriage Bill, a lot still needs to be done, the Congress MP said.

While expressing his views on the amended triple talaq bill, Dalwai triggered a controversy by saying, "Women are being treated unfairly in all communities, not just Muslims, even Hindus, Christians, Sikhs etc. In every society, there is male domination. Even Shree Ram Chandra ji once left Sita ji after doubting her. So we need to change as a whole." Dalwai later clarified on his remarks made on Lord Ram.

The Congress MP said that he is a devotee of the deity too. But, what he said was meant to highlight the fact that even Hindu women had suffered a lot since the ancient times.

The Maharashtra Congress leader, however, said that what he said was not meant to malign any religion. Dalwai had last year written to



Union Home Minister Rajnath Singh, saying the move to criminalise the practice of triple talaq was 'extremely problematic'.

The Congress MP said that while he was opposed to the practice of triple talaq in principle, the government's move was selectively targeting Muslims. BJP's Rakesh Sinha, an RSS ideologue who was recently nominated to the Rajya

Sabha, hit back at Dalwai, saying that he has no right to drag Lord Ram's name in the debate over triple talaq. Those opposing the triple talaq bill had the Taliban-like mindset, Sinha said. Several BJP MPs too raised objections to Dalwai's statement in the Rajya Sabha and the demanded the same to be expunged. Law Minister Ravi Shankar Prasad today urged the Congress to support the amended triple talaq Bill. Prasad said the bill seeks justice for crores of women. However, UPA chairperson Sonia Gandhi today said that her party's stand on the triple talaq bill is quite clear. The war of words between the government and the Congress-led Opposition comes at a time when ruling side is preparing to push the much-debated triple talaq Bill in Rajya Sabha on Friday. - Exceptional items for the current quarter include:
 - Write down in inventory value of Rs. 21.11 crores, pursuant to the company executing a Memorandum of Understanding (MOU) on June 29, 2018, to sell a land parcel situated at Patancheru village, Hyderabad, for consideration of Rs. 95 crores.
 - Impairment of investments and loans given to wholly owned subsidiaries of Rs. 117.80 crores towards proposed SEZ projects in Goa. The State Government had allotted land for the SEZ projects which was subsequently cancelled by the High Court. The Company's Petition against the High Court order was disposed off by the Honorable Supreme Court vide its order dated July 31, 2018, upholding the State Government order to take back the land and refund the amount along with simple interest, resulting in the aforesaid impairment.
